The successful bidder, if using a (10%) bid guaranty, shall be required to provide a contract performance and payment bond for the full amount of the bid.

Ohio Department of Transportation Construction and Material Specifications dated January 1, 2005 shall apply. Work shall consist of preparation and sealing of pavement cracks or joints with hot applied crack sealant in accordance with ODOT Item 423, Crack sealing, hot applied, Type I.

Material shall be applied flush with existing pavement. If excess material is applied, a squeegee shall be used to level the material.

The contractor shall sand finish as directed by the Township Trustees to prevent tracking.

All work and material contracted for seal coating shall meet the requirements of the 1997 State of Ohio, Department of Transportation, Construction and Material Specifications. All other work shall meet the requirements of the State of Ohio, Department of Transportation, Construction and Material Specifications dated January 1, 2005, together with any modifications to the same stated herein.

Spreading and placement of asphalt shall be done with full width paving equipment.

“Formed” or “Butt Type” construction joints shall be constructed at all pavement termini unless otherwise directed by the Township Trustees.

The asphalt binder grade for all asphalt concrete specified shall be PG 64-22.

Aggregate used in the asphalt concrete mix and for seal coating shall be State approved quarry run mineral aggregate.

Cut back asphalt may be used on applicable bid items between the period of October 15th and April 15th.

There are no restricted construction dates for the use of cut backs for penetration prime coat, maintenance mix or dust control.
