In the event that the Contractor fails to make repairs, adjustments or complete other work which may be required by such defects, the Trustees may do so and charge the Contractor the costs incurred.

The Board of Trustees reserve the right to award separate contracts on the various roads described. The Board of Trustees further reserves the right to reject any or all bids.

The seal coating work shall be completed on or before October 31, 2009.

For each calendar day that any work shall remain uncompleted after the stated completion date the appropriate sum, in accordance with the schedule of liquidated damages per Section 108.07 of the Standard Specifications of the State of Ohio Department of Transportation, will be deducted from any monies due the Contractor, not as a penalty but as liquidated damages; provided however, that due account shall be taken of any adjustment of the completion date granted by the Board of Trustees of Damascus Township.

A work day will be counted as lost if the Contractor's efficiency is reduced more than fifty (50%) percent on the critical items under construction at that time. Weekends and holidays will not be counted as lost work days.
