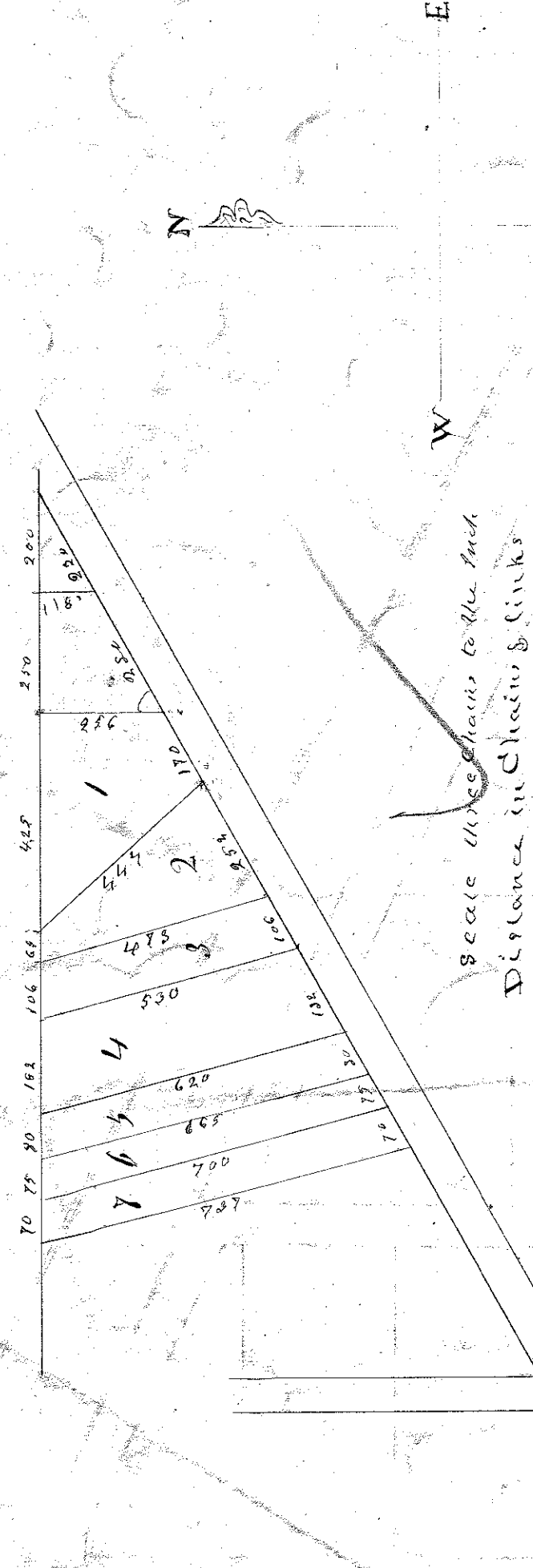


PLAT OF EDWARDSVILLE.

Being an subdivision of a part of the North East quarter of the North West quarter of Section Twenty eight 28 Town three North (31) Range seven (7) East in the County of Henry and State of Ohio -



Field notes to Edwardsville

being a subdivision of a part of the North East quarter of the North West quarter of section Twenty Eight 28 Township No Three (31) North of Range No seven (7) East in the Sth County of Henry and State of Ohio commencing at the North quarter Post of section Twenty Eight (28); thence South 250 chains to the center of the Ridge Road; thence South 61° West 2.65 to the corner of Lot No 1 & 2; thence North 50° West to the North line of the Road; thence South 61° West 2.63 chains; thence North 15° West 7.39; thence East 100 chains to the place of beginning the lots being subdivided into lots as shown on the plat. Thence South and eighth as marked on the lines of each lot containing 7.60 Acres surveyed Feb 6th 1869 by Suburban County Surveyor. The George W Edwards and John Rayle do hereby certify that it is the order of the land in which the annexed Plat of Edwardsville Henry County Ohio is located that the same was surveyed and plotted as our request and in accordance with our instructions of W Edwards. John Rayle.

Copy of Probate Record & Plat of Field Notes of Edwardsville Henry County Ohio

Be it remembered that hereupon to wit on the 22 day of June A.D. 1869 Virginia C. Smith Guardian of Mary W Smith minor Child of W. J. Smith deceased John in the Probate Court of Henry County Ohio a Petition in the case and again following in the words of the Petitioner Virginia C. Smith and her guardian of said County of Henry and State of Ohio. Your petitioner Virginia C. Smith represents that she is the duly appointed and qualified guardian of Mary W Smith now of the age of three years and residing with the undersigned in Clinton County Ohio that said Mary W Smith is the only child and legal representative of W. J. Smith late of Henry County Ohio now deceased that the said W. J. Smith died seized of the following real estate viz the North East quarter of section 31 and part of the South West quarter of the South East quarter of section 30 Township five (5) North of Range 6 East which lies south of the Toledo and Kalamazoo Rail way in Henry County and State of Ohio. That some time prior to the death of W. J. Smith which took place on or about the 10 day of July 1869 he became anxious of having a portion of said lands conveyed into Town Lots and did procure a survey and Plat thereof to be made a correct copy of which is attached to this petition and made a part thereof and made contracts with sundry persons for the sale of certain lots included in said survey and Plat but your petitioner avers that before the said Plat could be properly acknowledged and recorded the said W. J. Smith died. It is further hereby represented that said real estate lies on the North side of the Toledo and Kalamazoo Rail way is an excellent business point at which there is a post office already established and a railway station at which a large amount of business is being transacted and that in view of these facts it will be for the benefit and advantage of the said Mary W Smith to sell some of said land as is included in the Plat aforesaid and also it will be for the benefit and advantage of the said minor to lay out her said land into such Town Lots. Your petitioner therefore prays that the said Mary W Smith may be soleficia of the said land and prayer of this Petition, and that your petition may be ordered to cause the said survey and Plat of the lands herein described to be acknowledged and recorded in order that the intent of the said Mary W Smith may be advanced and the intentions of the said W. J. Smith in the premises fully carried out. Virginia C. Smith guardian of Mary W Smith. By S. M. Wagner her attorney. And afterwards to wit on the 1st day of October A.D. 1869 by order of said Court of Probate then issued a notice to the defendant in accordance with the prayer of this said Petition in the words and figures following to wit: To Mary W Smith you are hereby notified that on the 22 day of June 1869 Virginia C. Smith is guardian of Mary W Smith aforesaid only child and heir at law of W. J. Smith deceased filed in the Probate Court of Henry County Ohio this object and prayer of which is to procure said Court to order a portion of the lands herein described to be conveyed into Town Lots and to cause a Plat thereof to be made acknowledged and recorded in accordance with law and the prayer of said Petition. That the said estate described in said Petition a portion of which is proposed to be conveyed into Town Lots is as follows The North East quarter of section 31 and that part of the South West quarter of the South East quarter of section 30 Township 5 North of Range 6 East which lies south of the Toledo and Kalamazoo Rail way in Henry County Ohio the application for said Order will be for hearing by said Court on the 10 day of Nov 1869 at 1 o'clock P.M. at which time unless you show cause to the contrary and order will be asked (unless as prayed for in the Petition.
