

Notes and references pertaining to the annexed Plat. The above Plat is a subdivision of Lot L so marked and described on the Plat and in the notes to the Town of Holgate Henry County Ohio. Said Plat is bounded on the N.W. by the Township line Road between the Townships of Pleasant and Flat Rock, on the West by the Section line Road between Sections 1 & 2 in Pleasant Township and on the East by Mill Creek Street so marked on the Town Plat of Holgate but generally known as Kaleda. The said area annexed Plat is the S.W. part of Section No 1 Pleasant Township Henry County Ohio. The figures on the Plat in black ink show the dimensions of the respective lots in chains and links also the width of the alleys. The lines East and W. through said Plat are at right angles to the section line West of said Plat. The number of the lots have been shown on the Plat in red ink. The Plat also shows the area of land contained in each lot in acres and hundredths of acres. Across + indicates a stone placed. The Plat of Ohio Henry County so. of Henry Hobbs Surveyor of said County certifies this to be a correct Plat notes and references to Euis Rock's Linden & Schrodgers subdivision of lot L in the Town of Holgate. 

J. W. Sargent's addition to Hamler



The above Plat represents an addition of 17 lots to Hamler as surveyed by me on the 18<sup>th</sup> day of December AD 1874 at the instance of the proprietor Mr. J. W. Sargent. Said addition with its streets and alleys comprises 4 acres of land and is described as the East part of the North East corner of the North half of South East 1/4 of Section 10 in Township three (3) North of Range Seven (7) East in Henry County Ohio. The lots, streets and alleys are of the size and width indicated in fact on the Plat. A stone is planted at the top first as shown said addition surveyor.
