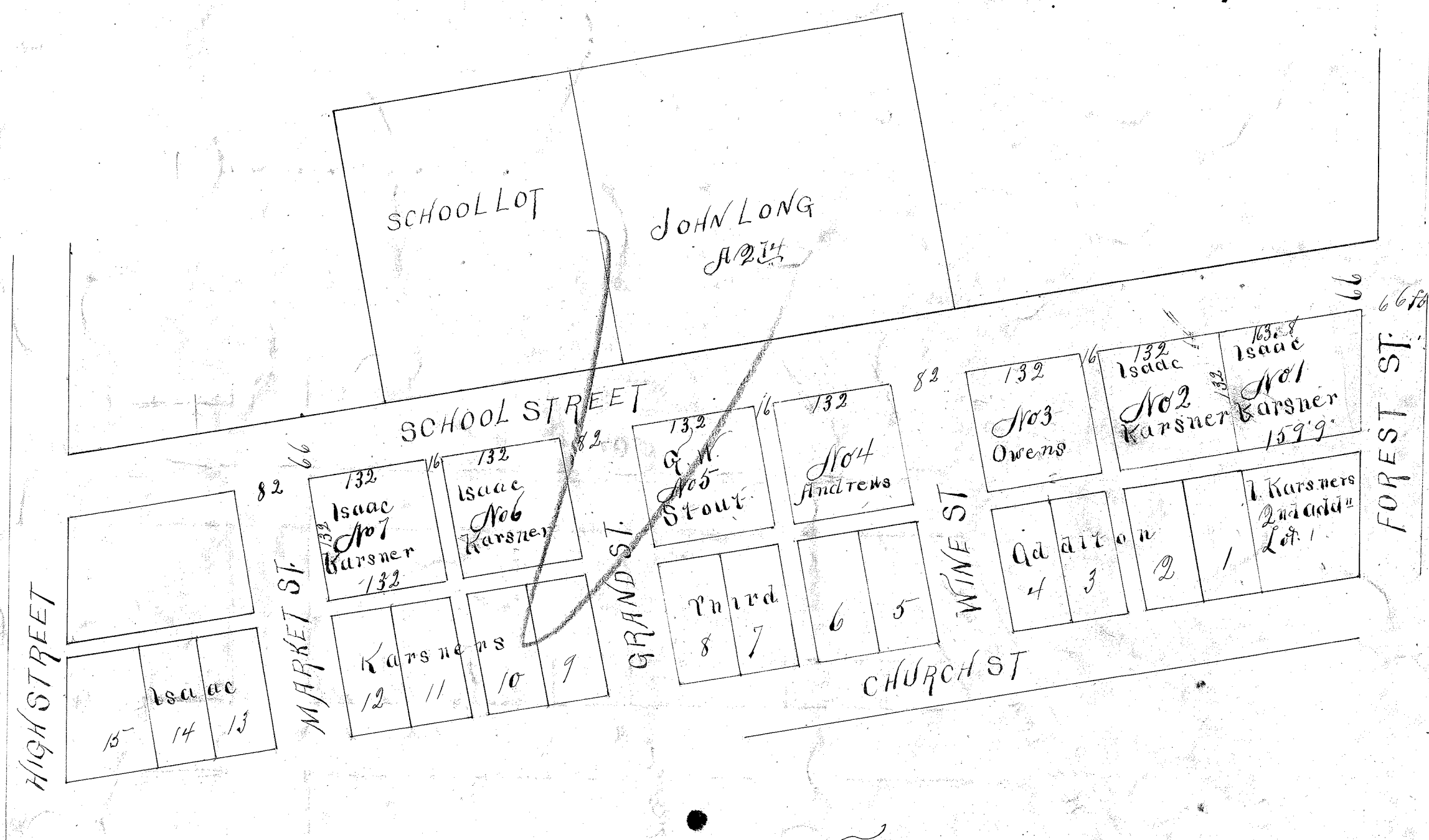




Field Notes

The Plat and Survey of Karsners Owens Andrews and Stout's Addition to the Village of Florida Henry County Ohio. The plat is situated in the E 1/2 of N 1/4 Section eight (8) Town four (4) North Range Six (6) East Henry County Ohio immediately north of Karsners second and third additions to said Village of Florida O. and is bounded as follows: Commencing at the (16) feet N. 1/2 degree West of the North East Corner of Lot No 13 in Isaac Karsners third addition to Florida (being on westerly side of Market Street extended and N. 3.00 Chains or 13 rods thence extending the westerly line of Market Street thence North eight degrees East and parallel with the northerly boundary of Karsners 2nd and 3rd Additions to the West line of Forest Street extended a distance of 18.45 Chains or 75 Rods & 20 links thence south along west line of Forest Street extended about 3.00 Chains or 12 rods thence S 80 N along the northerly line of Karsners 2nd and 3rd Addition to the Village of Florida a distance of 18.80 Chains to the place of beginning. The area of land contained in this Survey and plat is 5.63 Acres which has been subdivided as shown and is represented on the Plat. Market Street extended, Grand Street extended and Wine Street extended are each Eighty two (82) feet wide Forest Street extended is sixty six (66) feet wide; Alleys extended are 16 feet wide and School Street is four rods or 66 feet wide Lot No 1 is 163 feet and 8 inches wide (2.48 Chains) on northerly line and 2.14 Chains or 157 feet and 7 inches on south line by 2.00 Chains or 132 feet deep. Lots Nos 2-3-14-5-6-7 are each 8 rods wide by 8 rods deep. The dimensions of the different lines of the lots and widths of Streets and alleys have been marked on the Plat in feet and inches in black ink while the numbers of the lots have been shown in red ink.

I hereby certify the foregoing Plat and Field Notes to be a true and correct representation of the Survey of Karsners Owens Andrews and Stout's Addition to the Village of Florida Henry County Ohio as made by me on the second day of December A.D. 1889 at the request and under the directions of the proprietors.
