Description & Explanation.

The land, represented by the annexed Plat, lies in the South East corner of the South West quarter of the South East quarter of section twenty five (25), Town six (6), North, Range seven (7), East, Henry County, Ohio; & contains five (5) & thirty-eight one-hundredths (38/100) acres of Land, including half of the street in front of Lots 1, 2, 3, 4, 5 & 6; & the alley; but excluding the tracts in the names of Anna Kemmerer & John Laver. The alley between Outlots No. 2 & 3 is only to be used for private benefit, & is not donated to the town; & contains 3/100 of an acre. The dimensions of the lots are marked in feet & inches on the margins, & the numbers are marked in the central part. The Out lots are numbered 1, 2, 3, 4, 5, 6; the inlots are numbered from 1 to 6 inclusive. No part of High Street is included, the dimensions above given.
