



Liberty Center O.  
Aug 11th 1905.

Under the direction of Frank W. Moyer  
I surveyed and laid into lots, streets & alleys  
the following property to wit:  
Commencing at the north west corner of  
Lot no six (6) in Raymond's addition to the Village  
of Liberty Center Henry Co. Ohio  
Thence north eighty six and three tenths (86.3) ft.  
Thence east thirty one and four tenths (31.4) ft.  
Thence northerly to a point one hundred and forty  
(140) ft. north and three (3) ft east of this angle.  
Thence east six hundred and twenty two (622) ft.  
Thence south one hundred and sixty (160) ft.  
Thence west one hundred and fifteen and  
six tenths (115.6) ft. Thence south two  
hundred sixty three and seven tenths (263.7) ft.  
Thence westerly along Wabash R.R. Right  
of way four hundred and forty four (444) ft.  
Thence north three hundred ninety five  
and one tenth (395.1) ft. Thence west one  
hundred and thirty two (132) ft. to place of beginning.

correct representation of said land surveyed

I planted permanent monuments marked as
