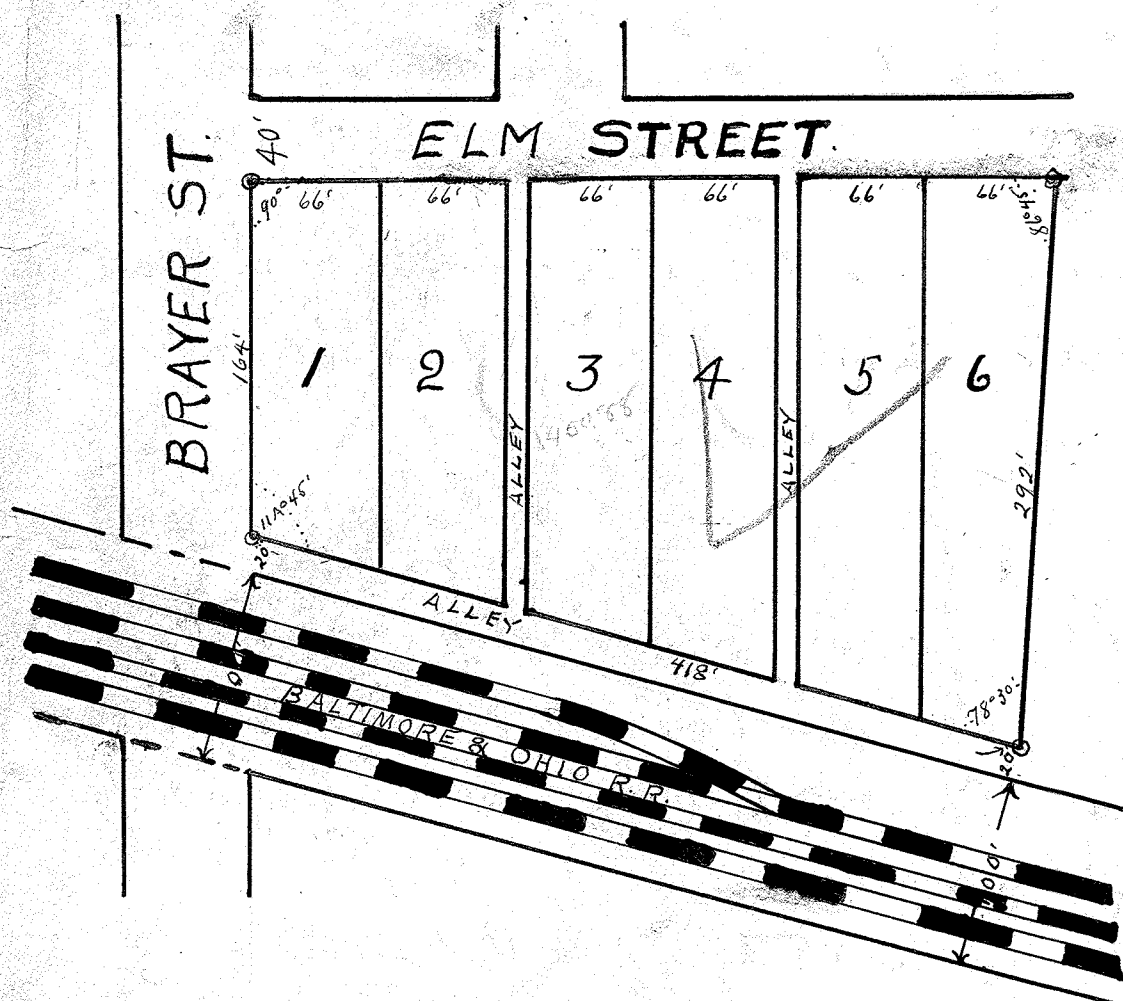


Plat Of
Ritz and Cole's Re-survey of Lots 436-438-
439-440-441-442 & 443 of Kauffman's
Addition to the Village of Holgate, Henry County, O.



Field notes to Ritz & Cole's re-survey of
Lots Nos. 436-438-439-440-441-442 & 443 Kauffman's
Addition to the Village of Holgate, Henry County, O.

Commencing at a point 788.7 feet West and
1109 feet South of the North-east corner of Section
Two (2) Pleasant Township, Henry County, Ohio, at an
iron gas pipe, which point is the North West corner
of Lot No. One (1); thence thence South a distance of 207.
feet to a gas pipe set in the North right-of-way of
the Baltimore and Ohio Railway; thence South-east at
an angle of 114 degrees and 45 min. a distance of 418
feet to a stake; thence North-east at an angle of 78
degrees and 30 min. a distance of 312 feet to an iron
gas pipe, which point is the North-east corner of Lot
No. 6; thence West at an angle of 86 degrees and 45
min. along the South side of Elm Street a distance of
420 feet to the place of beginning.

An iron gas pipe is set at the North-west and South-west corners of Lot No. 1, and the North-east and South-east
corners of Lot No. 6, in conformity with the State Law relative to platted lands in an incorporated Village.
The dimensions of Lots and alleys are shown on the plat, as well as the Number of the Lots, in black ink, a strip
Five (5) feet wide has been reserved off of the North end of all Lots for sidewalk purposes, this making the South line of
Elm Street the outside line of sidewalks. Surveyed April 12th, 1916, by T. A. Gamm Deputy County Surveyor.

We, Chas. L. Ritz and Amelia B. Ritz, his wife; Guy O. Cole and Clara M. Cole, his wife, hereby certify that the foregoing
Survey and Plat was made at our request, and in accordance with our instructions, and we hereby adopt the same as a re-survey
of Lots Nos. 436-438-439-440-441-442 & 443, Kauffman's Addition to the Village of Holgate, Henry County, Ohio, and give and
dedicate the Streets and Alleys shown thereon to public use; except the Streets and Alleys heretofore made public.
